FOOD VENDORS

Vendors will receive a 10-by-10-foot space for the day. Vendors bring their own canopy, table, chairs, and trashcan. **All food vendors must obtain a Multnomah County Health Department permit 503.248.3400 (www.mchealthinspect.org)** If using propane, you must obtain a permit from the Fire Prevention Division 503.823.9700. **No onsite BBQ. No electricity available. Only quiet generators will be allowed.** All vendors must follow Hawthorne Street Fair rules and regulations. Vendors are responsible for their own items and sales. **We also would appreciate it very much if you can bring a trash container for your booth and carry out your own trash – boxes, bottles, leftover food, etc.**

Setup starts at 8:30 am, fairgoers begin to arrive around 11:00 - the official event start this year. Please let us know in advance if you plan to leave before the end of the event, otherwise you are expected to keep your booth open until 6 PM.

To sign up, fill out this form & enclose payment or pay by paypal. A confirmation letter will be **emailed**. Locations assigned in the order that payment & registration forms are received. **Vendors must sign liability waiver.**
